The outcome of a school's accreditation depends upon the members of the survey visit team.



The LCME accepts the element performance ratings suggested by the survey team.



LCME teams are required to address every element during a survey visit.



The LCME requires in-person visits by senior administration to each of the medical school's regional campuses.



The LCME will cite a school solely on the basis of student opinion.



We should not change the curriculum when we have an LCME accreditation visit coming up.



If the school has a policy that all final grades must be submitted within four weeks of the end of a course/clerkship, the LCME will judge the school according to this criterion.



The medical school must provide health insurance to its students.



The LCME has formulas by which it determines whether a particular element is satisfactory, a particular standard is compliant, and whether the medical education program is granted a full, eight-year term of accreditation versus a "severe action."



There is an LCME version of the "hidden curriculum," that is, the LCME has a set of unwritten standards which is not published but to which schools are held.



The LCME has an unwritten rule that "20% student dissatisfaction equals an automatic citation."



In evaluating AAMC GQ data, the LCME uses percentile differences between the school's respondents and national means.



All campuses must provide students with opportunities for biomedical research.



The LCME expects that all policies are dated and approved by the faculty council/assembly.



The LCME has removed the Element 3.3 DCI tables that ask about diversity of faculty and senior administrative staff, but still expects the school to collect these data.



All standing committees must have representatives from all campuses.



Survey teams and the LCME pay no attention to the number/percentage of N/A responses to student survey questions.



If School A has a policy, practice, or system that the LCME has judged to be satisfactory, and School B implements the same policy, practice, or system, then the LCME will judge School B also to be satisfactory in that area/element.



Required clinical settings (Element 6.2) must be either inpatient or outpatient; listing the setting for an encounter as both inpatient and outpatient is unacceptable.



Beware of seeking advice from or consulting with the Secretariat because this could have a negative impact on accreditation decisions.


